3.2 Automatically Collected Information

Our website (hosted on Wix) automatically collects:

- IP addresses (anonymized)
- Browser type and version
- Time zone setting
- Operating system and platform
- Pages visited and navigation patterns
- Google Analytics data (GA4)



3.3 Cookies

We use cookies through our Wix platform. For detailed information about the cookies we use, please see our separate Cookie Policy. You can manage your cookie preferences through your browser settings.

4. How We Use Your Data

We process your personal data for the following purposes:

4.1 Contract Performance

- Analyzing website performance and user behavior
- Following up with prospective clients
- Maintaining security of our systems

5. Data Storage and Security

5.1 Storage Systems

We store data across the following platforms:
